Privacy Policy

Collection of your Personal Information

We do not collect any personal information about you unless you voluntarily provide it to us. As a staffing agency, we connect nurses (CNA, LVN, and RN) with facilities in their area. Those facilities post open shifts and our contracted nurses can pick up available shifts listed on their calendars.

Clipboard Health may share data with trusted partners to deliver services. All such third parties are prohibited from using your personal information except to provide these services to Clipboard Health, and they are required to maintain the confidentiality of your information.

Clipboard Health may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Clipboard Health or the site; (b) protect and defend the rights or property of Clipboard Health; and/or (c) act under exigent circumstances to protect the personal safety of users of Clipboard Health, or the public.

Tracking User Behavior
